



RULES OF CONDUCT

The Galleria of Mt. Lebanon is private property. To provide a safe, secure, and pleasant environment, the Galleria of Mt. Lebanon requests your cooperation in complying with the following “rules of conduct”.

- 1. The Galleria is for shopping.** Treat others as you like to be treated. Appropriate behavior does not include fighting, harassment, offending others or provoking confrontations or disruptive conduct of any nature.
- 2. Act responsibly. Please refrain from...**
 - Shouting, making loud noises or using indecent language
 - Playing loud music other than what the Galleria provides
 - Defacing, damaging, or destroying any property belonging to the Galleria, its patrons, or its tenants
 - Assembling in a manner which disturbs the public peace
- 3. Allow others to shop safely and comfortably. Please...**
 - Do not block access to store entrances and corridors or parking areas.
 - Do not move tables, chairs, or any other furniture for any reason.
 - Walk; don't run, skate or skateboard.
 - Recreational use of bicycles is prohibited on the property.
 - Use our benches and chairs for sitting.
 - Animals must be leashed and well-behaved. No animals are permitted on escalators.
 - Do not leave animals unattended in parked cars.
 - Do not take strollers or wheeled equipment on escalators.
 - Underage children must be supervised by an adult and may not gather in groups. Unaccompanied minors will be asked to leave the mall.
 - **WEAPONS OF ANY TYPE ARE NOT PERMITTED ON THE GALLERIA PROPERTY.**
- 4. Observe all Federal, State and Local Laws.** Use of alcoholic beverages is restricted to designated areas.
- 5. Please dress appropriately and observe all health codes and local laws.** Clothing should not be worn which is obscene or offensive in nature.
- 6. Smoking is only permitted in designated exterior areas. The use of electronic cigarettes inside the mall is prohibited.**
- 7. Please visit the Galleria Office to request permission to take photos or recordings on the Galleria property or of any mall storefronts.** Without prior, written permission from the Galleria of Mt. Lebanon, no such activity is permitted.
- 8. Distribution of literature, solicitation, demonstrations, and special promotions or using the property for any purpose other than shopping is prohibited without prior written permission from the Galleria.** If permitted by law or if you have any questions please visit the Galleria of Mt. Lebanon management office for more information.
- 9. When the Mall and stores are closed, please leave.** Please do not park or loiter on the property after closing. Unauthorized vehicles parked overnight may be towed at Owner's expense.

Please follow these Rules of Conduct. If you do not, we will ask you to leave and stay away for a specified period of time.
